**Explanation of Responses:**

- The date of grant was March 20, 2015, and the shares vest as follows: 40% becomes exercisable on the 2nd anniversary of the date of grant, and an additional 20% vests on each of the 3rd, 4th and 5th anniversaries of the date of grant.
- Each restricted stock unit represents a contingent right to receive one share of Class A Common Stock.
- The restricted stock units vest in installments of 15%, 15%, 15%, 15% and 40% on the 13th-month, 2nd, 3rd, 4th and 5th anniversaries of the date of grant (March 20, 2015), respectively.
- These restricted stock units vest on the transaction date.
